



OPERATION



DO NOT place the unit:

- Directly on or near soft furnishing (such as bedding or curtains)
- Near electronically sensitive device such as a computer (within 6 in / 10 in)
- Near sources of heat (such as radiators, fireplaces or ovens)
- · Near oxygen tanks or other combustible gases
- Near water, outdoors or in a damp or wet areas (such as bathrooms)

OPERATION (CONTINUED)

- 1. Take your ActivePure® Beyond Guardian unit out of the shipping carton and remove all protective materials.
- 2. Place the unit in a location away from the wall that allows air to move freely into, around and out of the unit. The rear of the unit requires 6 inches or more of open area to allow unrestricted airflow.
- 3. Attach cord to unit, if required. Plug the cord into a working electrical outlet.
- 4. When turning the unit on, turn the speed control to MAX airflow for a few minutes of fast initial purification.
- 5. After a few minutes, adjust the control to the desired speed.

NOTE: Safety switch automatically turns power off when door is opened.

SETTINGS


When turning the ActivePure Beyond Guardian on, turn the speed control to maximum airflow for a few minutes of fast initial cleaning. Then adjust the control to the desired speed.

There are four settings on the ActivePure Beyond Guardian:

- HEPASilent™ (low fan speed)
- 2. Moderate fan speed (for normal use)
- 3. High fan speed (for a large room)
- 4. Maximum operation (for fast initial cleaning)

For best results, run your ActivePure Beyond Guardian 24 hours a day, 7 days a week, giving you the benefits of ActivePure Technology day and night.



- All major parts are made from high-quality galvanized steel, not plastic; the steel housing is noise-muffling, providing quiet operation; the external parts have been powder coated for endurance and environmental protection
- The ActivePure Beyond Guardian is energy efficient; from lowest to highest speed, it uses from 23 to 80 watts no more than a lightbulb
- ActivePure® air purification systems are built for years of use

The ActivePure Beyond Guardian features award-winning design, materials and workmanship. Keep your unit in top condition with these cleaning tips:

- Always unplug unit before cleaning
- Wipe the exterior with a soft, clean, damp cloth
- Vacuum the small inlets on each end panel with a soft brush attachment
- Clean inside the ion chamber by opening the front door of the unit and opening the door of the ion chamber (right-hand side)
- · Never clean with gasoline, chemical solvents or corrosive materials they may damage the surface



FILTERS

ActivePure® HEPA technology makes the ActivePure Beyond Guardian incredibly quiet. Units come with one HEPASilent™ particle filter (installed).

The ActivePure® HEPA particle filter is made of polypropylene, which mechanically filters out airborne particles (dust, pollen, pet dander, mold spores and other airborne particles). To maximize filter effectiveness, particles are negatively charged before reaching the filter.

For optimal performance, ActivePure® recommends that you replace filter at least every 6 - 12 months, depending on usage.

NOTE: Use only ActivePure® HEPA particle filters to ensure proper functioning and to qualify your unit for full warranty coverage.

ACTIVEPURE® CELL ASSEMBLY

Disconnect power before changing filter.


STEP 1:

Open the front door from the right hand side.




STEP 2:

Remove old filter.




STEP 3:

REPLACING THE ACTIVEPURE CELL ASSEMBLY





UV Light in operation; disconnect unit from power source before servicing; failure to follow warnings may result in severe eye damage.



For optimal performance and to maintain the Limited 5 year warranty, it is required to replace the ActivePure Cell Assembly once every 12 months, even if the ActivePure Bull appears to be operating normally.

- Step 1: Always disconnect (unplug) unit from electrical power source before replacing the ActivePure® Cell Assembly.
- **Step 2:** If necessary, relocate the unit to an appropriate area to perform cell replacement.
- **Step 3:** Remove the 4 screws securing the old cell mounting plate on the unit.
- **Step 4:** Slide the old ActivePure Cell Assembly out of the unit and disconnect the bulb socket.
- **Step 5:** Open the replacement cell carton and remove the new ActivePure Cell Assembly.
- **Step 6:** Place old ActivePure Cell Assembly inside the empty new cell carton and dispose of properly.
- **Step 7:** Reattach the bulb connection to the new ActivePure Cell Assembly.
- Step 8: Slide the new ActivePure Cell Assembly back inside the unit and secure with the 4 screws removed in Step 3.
- Step 9: The ActivePure Beyond Guardian is now ready to be used.









WHAT IS COVERED BY THIS WARRANTY

We warrant the ActivePure Beyond Guardian (excluding filters) to the consumer, subject to the conditions below, against defects in workmanship or material, provided that the products are returned to a service location within the following time periods:

- ActivePure Beyond Guardian within three (3) years from date of purchase
- ActivePure Cell Assembly within one (1) year from date of purchase

MAINTENANCE REQUIREMENTS

This warranty is expressly conditioned upon proper installation, operation, cleaning and maintenance, all in accordance with the Owner's Manual. Failure to meet any of these requirements will void this warranty. Servicing of your ActivePure Beyond Guardian by parties other than our authorized representative and/or using parts other than genuine parts will also void this warranty. This warranty is contingent upon:

- Replacing your HEPA filters with genuine ActivePure filters every 12 months if run 24/7; if run 12 hours or less per day, the filter should be changed every 24 months (proof of change required)
- Replacing the ActivePure Cell Assembly with a genuine ActivePure part once every 12 months (proof of change required)

HOW TO OBTAIN WARRANTY SERVICE

Customers must contact their ActivePure sales representative or Customer Service and provide proof of purchase within the above time periods. We will repair or replace and return the product, without charge and within a reasonable period of time, subject to the conditions in the above paragraphs, if its examination shall disclose any part to be defective in workmanship or material. If we, in our discretion, are unable to repair the product after a reasonable number of attempts, we will provide either a refund of the purchase price or a replacement unit, at the company's option.
